As a result of a recent conversation with Shawn Harmon, I am writing this letter of complaint pursuant to my obligation under WAC 180-86-110. The above referenced Certificated Employee was a former employee (physical education teacher) of the Lake Chelan School District. On May 1, 2019, I was informed by the Chelan County Sheriff's Office that Mr. Rutter, (227125B) was arrested and booked for the alleged offense of Child Molestation in the 1st degree.

The case number assigned by the Chelan County Sheriff's office is 19C02185.

Apparently, the allegation was the result of an incident that occurred eight years ago at Morgen Owings Elementary School. Mr. Rutter, (227125B) has been informed through a district certified letter that he is not to be on a school campus or at any school events until further notice.
