SUBJECT: Interview with Jason Stonum D. O. B 8/31/73

On December 10, 1990, Jason Stonum was interviewed at the Centralia office of the Department of Children and Family Services. Present during this interview were "Spike" Millman, Investigator Internal Affairs, Ray Jordan, Social Worker for Jason and Dennis Auve, CPS Intake Worker.

Purpose of Interview was to determine if a CPS report and a Law Enforcement Referral would be made regarding an alleged incident that occurred at St. Peter's Hospital on or about October 14, 1990.

Jason was asked some of the following questions?

Q: When were you at St. Peter's Hospital Emergency Room?
A: October

Q: Who took you?
A: Guy

Q: Who was with you at the Hospital?
A: Guy and Chuck.

Q: Had Chuck been drinking?
A: Don't know.

Q: Did Chuck touch you?
A: Yes.

Q: Where did Chuck touch you?
A: Don't remember.

Q: Did Chuck call you Dear, Sweet, Honey, etc.?
A: Might have said "son".

Q: Has Chuck ever touched you before or after you went to St. Peter's?
A: Possibly a pat on the back.

Q: Back to the night at the Hospital, do you remember if Chuck had been drinking?
A: Guy told me Chuck was drinking, I couldn't smell it.

Q: Did it bother you that Chuck rubbed your legs, stomach and back?
A: At that time I was concerned about other things, not aware of Chuck touching me.

Q: Does it bother you now?
A: I am now more aware and it does bother me now that I think about it.

Q: Can you demonstrate or show us where and how Chuck touched you?
A: No, I was concerned about other things at that time.

Q: Were you dressed?
A: Yes.

Q: Where were you?
A: Sitting on gurney.

Q: Did Chuck touch you on your genitals?
A: No.

Summary:

Unable to support that the touching done by Chuck McCarthy on or about October 14, 1990 was sexual in nature. That the current information available is not sufficient for a CPS assignment or referral to law enforcement. Nor does it support that Jason is at risk and needs to be removed from Kiwanis.
