Get together your articles of incorporation and by-laws, your financial statement and other pertinent information necessary to develop an offering brochure, or information brochure to give to the people and institutions that they had indicated would be likely contributors. I met with no resistance to those requests. I further went on to discuss the need to retain the services of a strategic planner and a competent grants writer to aid in this process. again I met with no resistance to these recommendations and was praised by Chuck for the ideas that I had offered. He told me that I was just what he needed. I was very encouraged and very happy to finally be able to offer some help to the Home. Chuck was telling me that I would get information from him and it never came. I was becoming discouraged and was prepared to totally withdraw my association with the Home. Then I received this letter from Sam Morehead along with a copy of corporation resolution one. I did not like the tone his letter and the resolution is probably one of the most carefully worded documents that I have come across in a long time. Owing to the tone of the letter and the corporate resolution it made me very suspicious of what was going on. Why was Chuck giving me all of this positive feedback and then trying to go to you people to cut my legs out from underneath me. I consulted my attorney regarding my legal obligations as a member of the board. I told him what had happened to me and asked him if he could give me a legal definition of a board of directors. What

he gave was a copy of Title 24 of the RCW which gives the authority for this corporation to exist. In it, it outlined our obligation as board members. our responsibilities as board members, it allows us total access to information regarding the operation of the corporation. If we are not interested in the intricate operations of this organization then we should not be on the board.

I and my club are committed to the successful continuation of the home. We are not involved here to hinder the operations nor does anybody have any personal vendetta against the Director. However, I do not intend to sit idly by while the director gets in the way.
