HE DIDN'T ANSWER, BUT LATER SAID HE

WORKS AT HAVEN HEAVEN SENT DONATIONS, CENTRALIA, PEARL STREET ACROSS FROM MINKS COUNTRY MARKET. I ASKED IF SHE WAS ONE OF THE
