Then ah he had left and went on and I was there Saturday, I wasn't feeling right and I tore up the office and he tried to confront me and I pushed him away and told him to leave me alone and I had gone to church the next day, Sunday, and got back at my time and he asked me, he wanted to talk to me in the car and he started bringing up a date, you know, when he was liable to be gone and I told him it was wrong and I didn't like it and I didn't know what to do and he got out of the car and I wanted to have dinner and he come to me and talked to me, I was in there by myself. And he started bringing up all this stuff and he took his tape recorder and the drum sticks and I had a tape there and I threw the tape at him and missed him and he went out and I told the (inaudible) what happened and I took off from the group home

We were setting at the group home in his car and ah he asked me "did I like it" and I said "no I didn't, I thought it was wrong and I didn't really want to talk to him again" I didn't want to at all and he, I had gotten out of the car

Okay, we've turned it over to Side 2.

Q The question I, I have right now is how do you get in the car to talk to him

A He had asked me to come to talk to him

Q And to listen to what he has to say

A Yeah

Q Okay. So then you leave the car and you go over to the dining hall
