FINAL ORDER
OF PERMANENT
REVOCATION

Thirty calendar days have transpired since the mailing to Jack Lee Turek of a Proposed Order of Permanent Revocation. Jack Lee Turek's failure to make a timely appeal of such order authorizes this agency to issue a Final Order of Permanent Revocation based on the Findings of Fact and Conclusions of Law set forth in the Proposed Order of Permanent Revocation. The following is hereby entered:

FINDINGS OF FACT

1. Jack Lee Turek was issued a Washington Education Certificate, No. 351560H, on March 7, 1997. That certificate currently remains valid.

2. Jack Lee Turek has pleaded guilty of a crime identified in Revised Code of Washington (RCW) 28A.410.090(2). Such a plea or conviction authorizes OSPI to permanently revoke the education certificate.

3. Jack Lee Turek pleaded guilty of Rape of a Child 1st Degree, RCW 9A.44.073. Mr. Turek was ordered to pay \$100.00 Victim Penalty Assessment and \$300.00 counseling costs for the victim. Mr. Turek must undergo sexual offender treatment and must have no contact with victim for the term of victim's life.

4. Good Moral character and personal fitness is a continuing requirement to maintain a Washington education certificate.

CONCLUSIONS OF LAW

1. OSPI has jurisdiction over Jack Lee Turek and over the subject matter of this action.

2. OSPI has shown by clear and convincing evidence that the Washington education certificate, No. 351560H, of Jack Lee Turek, should be revoked, as provided for in WAC 180-86-075.


